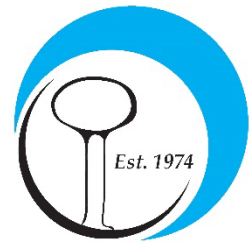

- Applicant/Member agrees to pay a **\$1,150** fee for tap on and connection to the Corporation's facilities, and a **\$50.00** Security Deposit before the water service becomes active. The deposit will be held by Clear Water until service is terminated, at which time it will be applied to the final bill. Any remaining balance will be refunded to the member.
- Applicant/Member agrees to pay a 10% penalty to each bill that is unpaid after the 12th of the month. If any bill remains unpaid after the 22nd of the month, the water supply to my property will be shut off by the Corporation, and service will not be restored until the delinquency and disconnect fee of **\$50.00** is paid in full.
- Applicant/Member agrees that unpaid bills shall constitute a lien upon my real estate, and legal action can be pursued to collect the delinquent charges.
- Applicant/Member accepts all responsibilities that the facilities are in accordance with all state and local requirements, to properly maintain these facilities, to maintain access to the service for the Corporation's employees and agrees that water service will only serve one household or business.
- Applicant/Member agrees as a condition of obtaining water service to grant Clear Water Service Corp. an easement across the above property as may be necessary for the construction, operation, and maintenance of the water line.

APPLICATION FOR WATER SERVICE

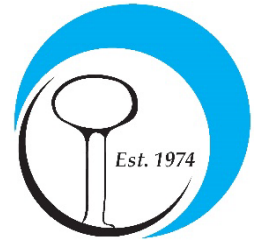
1. Applicant will, when water service becomes available, purchase from the Corporation water service used on the premises and will pay therefore at rates which will be fixed by the Board of Directors of the Corporation.
2. Applicant agrees to pay for the water service provided or available according to the rate schedules of the Corporation.
3. Applicant will comply with and be bound by the provisions of the By-laws of the Corporation and such rules and regulations as may, from time-to-time, be adopted by the Corporation.
4. Applicant shall not resell any water purchased from the Corporation.
5. Applicant will cause the premises of the applicant where the water service is to be provided to be plumbed in accordance with local and state requirements.
6. Applicant agrees to furnish the Corporation with a detailed drawing to scale showing the location of all underground wires, conduits, pipes, tiles, drains, sewers, drainage structures and any other underground installations located along the course of the proposed underground service installation and is responsible for any damage thereto not due to negligence on the part of the Corporation.
7. The acceptance of the application by the Corporation shall constitute an agreement including the terms stated above. If no other acceptance is made by the Corporation, the furnishing to the Applicant of the service requested in this application shall be deemed acceptance of the application.

APPLICATION FOR MEMBERSHIP

1. Applicant desires water service and will execute an "Application for Water Service."
2. Applicant will comply with and be bound by the provisions of the By-laws of the corporation, and such rules and regulations as may, from time to time, be adopted by the Corporation.
3. Upon acceptance of this application by the Corporation the membership shall be deemed a Joint Membership where application has been made by husband and wife jointly, and any subsequent "Application for Water Service" shall be deemed joint, though the spouse may not have actually signed the latter.
4. Applicant shall not resell any water purchased from the Corporation.
5. The acceptance of this application by the Corporation shall constitute an agreement between the Applicant and the Corporation including the terms set forth above. The Applicant, upon receipt of service from the Corporation, shall be issued membership in the Corporation and shall thereafter be a member of the Corporation.

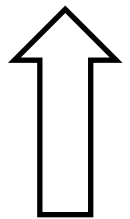
